Frankfort Community Unit School Dist # 168 is currently accepting annual bids for the 2017-18 school year.

The USDA has released new federal regulations for the NSLP and SBP beginning in the 2012-13 school year. These new regulations will greatly change the types of products normally ordered by each participating school district. To ensure all federal regulations are met for 2017-18, a detailed specification for products bid is attached to this letter.

Please note the following requirements for the 2017-18 Annual Bid process:

- Frankfort Community Unit School Dist # 168 will accept Escalator Bid Pricing for the 2017-18 school year. June 2017 escalator pricing must be returned with the final bid for consideration.
- All bidding companies must complete the attached Dairy Worksheet for bid consideration. For items not listed on the worksheet, attach spreadsheet with coordinating June 2017. escalator pricing.
- A minimum delivery of 2 days per week per school district location is required unless otherwise agreed upon between Distributor and Frankfort Community Unit School Dist # 168.
- All stock must be rotated upon delivery.
- All vendors must agree to return all outdated product each week if necessary. Credits for returned product must be issued to the school district within 7 business days.
- If equipment (i.e. milk cooler) is part of the formal bid returned, a letter stating the requirements and maintenance agreements must be included in the final bid for consideration.
- All bidding companies must be able to deliver specific product to ALL district locations. If multiple depots are required for delivery, please submit one bid for pricing regardless of delivery origination.

Bid Specifications for School District Dairy Products

2017-2018 School Year

On January 25, 2012, the USDA revised the Milk Component regulations for the National School Lunch Program (NSLP) and the School Breakfast Program (SBP). These new regulations will take effect on July 1, 2012 for the 2012-13 school years and forward. The USDA will require that all Dairy items served in schools meet the below specifications by the 2017-2018 school year.

Based on these new USDA regulations, to qualify for the NSLP and SBP program the specific bid specifications for Dairy products served in school districts must meet the requirements below. All Dairy Bids submitted for the 2017-2018 school year **MUST** meet these specifications.

White / Unflavored Milk

- A serving of Milk remains at 8z or Half Pint.
- The USDA rule allows for only Fat Free or Low Fat options in White / Unflavored Milk.
- Bid only Fat Free / Skim or 1% White Milk in Half Pints.

Flavored Milk

- A serving of Milk remains at 8z or Half Pint.
- The USDA rule allows for only Fat Free or Skim options in Flavored Milk.
- Bid only Fat Free or Skim Flavored Milk in Half Pints.
